- 13-01-08 1 The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.

- 13-01-08 3 Coleman McAllister, Sioux County Attorney
 - Motion by Bloemendaal and supported by Wright to set the time and date for a public hearing to readopt Sioux County's existing Code of Ordinances. Motion carried, unanimous in favor.

SUMMARY AND NOTICE OF PUBLIC HEARING ON PROPOSED SIOUX COUNTY ORDINANCE NO. 14

<u>Title of Proposed County Ordinance No. 14</u>: An Ordinance readopting the existing county Code, Sioux County, Iowa.

<u>Purpose of Proposed County Ordinance No. 14</u>: Section 331.302(10) (a), Code of Iowa, requires that once every five years a County shall compile its code of ordinances.

<u>Summary of Proposed County Ordinance No. 14</u>: The proposed County Ordinance would readopt and renumber county ordinances that comprise the existing County Code. Copies of the full text of proposed County Ordinance No. 14 and the complete County Code are available for public review at the office of the Sioux County Auditor, Courthouse, Orange City, Iowa.

Notice of Public Hearing on Proposed County Ordinance No. 14: A public hearing is scheduled for 9:30 o'clock a.m. on January 22, 2013, in the Board of Supervisors' Room, Court House, Orange City, Iowa.

Meetings of Board of Supervisors at which Proposed County Ordinance No. 14 will be considered: The Sioux County Board of supervisors will consider the passage of this ordinance at a public hearing scheduled for the same time and place as that to be held on proposed County Ordinance No. 14. Should said ordinance be passed at the meeting, the proposed ordinance will be considered at a second Board of Supervisors' meeting to be held on January 29, 2013, at 10:00 o'clock a.m. unless such requirement is suspended by a recorded vote of not less than a majority of the supervisors pursuant to Iowa Code Section 331.302(6). Should the proposed Ordinance No. 14 be approved, it will then be published and will be effective upon its publication.

RESOLUTION 2013-02

CONSTRUCTION EVALUATION RESOLUTION

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2013 and January 31, 2014, and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF SOUX COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).
