Replacement Schedule:

Moving of barbed wire fence	\$2.50/strand/rod
Moving of woven wire fence	\$10.00/rod
Moving of barbed wire over woven wire fence	\$1.00/strand/rod

Fence replacement payment will be based on the established price for the type of fence

removed.

Fence replacement payment for existing fence removed and replaced with a fence of lesser structure will be based on the established price for the fence of lesser structure.

Fence replacement payment for existing fence removed and replaced with a fence of greater structure will be based on the established price for the existing type of fence

removed.

Fence must be replaced within one (1) year from date of removal to receive fence

replacement payment.

Carried, unanimous in favor.

Motion by De Haan and supported by Smith to approve and sign a certificate

appointing the required number of real estate owners in townships, real estate owners in

cities, real estate brokers and bankers in Sioux County to serve on the County

Condemnation Board for Eminent Domain in compliance with Section 6B.4, 2000 Iowa

Code as Amended, as shown on file in the County Auditor's Office. Carried, unanimous

in favor.
