- **09-03-31 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Al Bloemendaal, Mark Sybesma, John Degen and Arlyn Kleinwolterink.
- **09-03-31 2** Minutes of the meeting held on March 24, 2009, were submitted and the Chairman declared them approved.
- **09-03-31 3** Coleman McAllister, County Attorney gave an update on the current jail population. Reported that the Sioux County Jail is doing a great job of offering opportunities for rehabilitation to inmates. Noted that Judy Plendl is very instrumental in connecting agencies with inmates.
- **09-03-31 4** Dan Altena, County Sheriff reported that the Jail is inspected annually.

- **09-03-31 5** Shane Walter, Community Services Director distributed the March monthly MH/DD expenditure report. Kleinwolterink thanked Walter for \$1,500 that was contributed to the Honor Flight program by the Veteran's Affairs Commission.
- **09-03-31 6** Doug Julius, County Engineer
 - Motion by Kleinwolterink and supported by Degen to approve and authorize the Chairman to sign a contract for bridge replacement: BROS-CO 84(125)—5F-84 approximately 1 ¼ miles west of K64 in Holland Township Section 19. Motion carried, unanimous in favor.
 - Motion by Wright and supported by Bloemendaal to approve a permit request from MidAmerican Energy to move a pole and install three anchors to enable Sioux County to pave a radius at the intersection of 360th Street and Garfield Avenue in Plato Township. Motion carried, unanimous in favor.
 - The five year construction plan was presented to the Board for approval. Motion by Wright and supported by Degen to approve the five year construction program and budget as presented by the County Engineer.

09-03-31 7 Committee Reports:

- Kleinwolterink reported on the Third Judicial meeting. Budget reduction was discussed. Building expansion is being planned.
- Kleinwolterink attended a Northwest Iowa Landfill meeting. A conflict of interest matter was resolved. The DNR is requiring a lining system for all new cells at landfills.
- Bloemendaal reported that he attended a Mid-Sioux Meeting. Mid-Sioux received \$1.9 million in federal stimulus money.
- Bloemendaal attended the Greater Sioux Community Health Center meeting. Bridge
 of Hope ministry in Sioux Center requested funding from the Board of Supervisors.
 The Bridge of Hope ministry has a garden and donates food from it to the food
 pantry.
- Degen reported that the Conservation Board has hired a new employee.
- Kleinwolterink updated the Board on the landscaping project at the Courthouse. Three vendors have submitted designs and bids to replace the landscaping around the perimeter of the Courthouse.
