RESOLUTION TO AMEND NURSE AND GENERAL WELFARE SERVICES DEPARTMENT BUDGETS

WHEREAS, proposed expenditures for the Nurse Department will cause this Department to exceed the amount budgeted for the fiscal year 2012-2013; and

WHEREAS, it is deemed necessary to increase the appropriations for the Nurse Department to not be in violation of Iowa Code Section 331.437; and

THEREFORE, BE IT RESOLVED by the Board of Supervisors that the appropriation for the following Departments be changed as follows:

Nurse Department be increased from \$337,724 to \$338,724

General Welfare Services Department be decreased from \$88,500 to \$87,500
