The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock A.M. with Chairman Loren Bouma presiding. Members present were William Vander Maten, Vernon Beernink, Loren Bouma, Bernard L. Smith and Hubert Schuller.

The minutes of June 24, 1997, were read and on motion and vote stand approved as read. Committee reports were given this date.

Dennis Sassman, Community Services Director, met with the Board this date to introduce Shane Walter, County Central Point of Coordination and Decategorization; and Ruth Vander Weide, Community Treatment Worker.

However, the coverage is still subject to the standard exclusions which are present in the General Liability contract which include the exclusion of the Pollution Hazard.


