- 12-07-24 1 The Board of Supervisors of Sioux County, Iowa, met on July 24, 2012, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.
- **12-07-24 2** Minutes of the meeting held on July 10, 2012, were submitted and the Chairman declared them approved.
- 12-07-24 3 Jon Buiter, Engineer from EDA presented an update on Phase II of the Courthouse air conditioner replacement project. A time table for the project was discussed. Work inside the building will likely begin in November with anticipated completion in June.
