- 12-08-28 1 The Board of Supervisors of Sioux County, Iowa, met on August 28, 2012, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright. Member John Degen was not present for this meeting.
- **12-08-28 2** Minutes of the meeting held on August 21, 2012, were submitted and the Chairman declared them approved.
- 12-08-28 3 Coleman McAllister, Sioux County Attorney, reviewed the information given to the Board last week in regard to beginning condemnation proceedings. A Public Hearing will need to be held to identify the road project and its' adjoining property. Motion by Bloemendaal and supported by Kleinwolterink to set September 11, 2012 as the date and 9:00 as the time for a public hearing to specify the road project for which the Board seeks to obtain right of way.  - The Tiling project on the West side of the Courthouse will begin on Tuesday, September 4.
