- **08-09-02 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:30 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, John Degen and Arlyn Kleinwolterink.
- **08-09-02 2** Minutes of the meeting held on August 27, 2008, were submitted and the Chairman declared them approved.

A RESOLUTION OF THE SIOUX COUNTY BOARD OF SUPERVISORS SUPPORTING THE COMMUNITY ATTRACTION AND TOURISM APPLICATION FOR THE BOYDEN SPLASH PAD PROJECT

- WHEREAS, the Boyden City Council has identified a need to make certain new recreational and entertainment improvements to the community through the installation of a new splash pad recreational facility; and the Sioux County Board of Supervisors fully supports the need for this project.
- WHEREAS, the project will be financed by private fundraising, and city, county and state financing, including an application to the State of Iowa for a Vision Iowa Community Attraction and Tourism (CAT) Grant.

- Opened bids for snow blades: Industrial Supply Solutions: \$47,038.50; Sioux City Foundry Co. \$33,030.00. Motion by Wright and supported by Kleinwolterink to accept the low bid from Sioux City Foundry Company pending review by the County Engineer.
- Reported that blading will increase because of additional traffic due to harvest.
