## **MEETING HELD ON SEPTEMBER 26, 2011**

- 11-09-26 1 The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright. Supervisor John Degen was not present at this meeting.
- **11-09-26 2** Minutes of the meeting held on September 16, 2011, were submitted and the Chairman declared them approved.
- 11-09-26 3 As this was the date and 9:00 a.m. the time set for a public hearing to approve a Voting Precinct Ordinance for Primary and General Elections, said meeting was opened by the Chairman. No public comment either written or oral was given at this meeting. The Chairman closed the public hearing. Motion by Kleinwolterink and supported by Wright to approve Ordinance No. 23 establishing voting precincts for Sioux County to be effective upon publication. Roll call on vote: Kleinwolterink, Yes; Wright, Yes; Bloemendaal, Yes; and Sybesma, Yes. Motion carried, unanimous in favor, one member absent.

## **ORDINANCE NO. 23**

# AN ORDINANCE ESTABLISHING VOTING PRECINCTS FOR SIOUX COUNTY, IOWA

BE IT ORDAINED by the Board of Supervisors of Sioux County, Iowa, that Sioux County Ordinance Number 17 is hereby repealed in its entirety and the following be substituted in its place:

- SECTION 1. <u>PURPOSE</u>. The purpose of this ordinance is to change established voting precincts for Sioux County, Iowa as a result of the 2010 federal decennial census per Section 49.8(6), Code of Iowa based upon the County Election Commissioner's recommendation and the County Board of Supervisors decision that finds that the change will affect a substantial savings in election costs.
- SECTION 2. <u>DEFINITIONS.</u> For use in this ordinance, the following terms or words shall be interpreted or defined as follows:
  - 1. "Voting Precinct" or "Precinct" shall mean a county or municipal subdivision for casting and counting votes in elections.
  - 2. "Township" shall mean a civil and political subdivision of the county, six miles on each side.
- SECTION 3. <u>GENERAL PROVISIONS.</u> Precincts established as provided by Section 49.8(6), Code of Iowa, shall be used for all elections, except where temporary merger of established precincts is specifically permitted by law for certain elections and no political subdivision shall concurrently maintain different sets of precincts for use in different types of elections.
- a. No precinct shall have a total population in excess of three thousand five hundred, as shown by the most recent federal decennial census.
  - b. Each precinct is contained wholly within an existing legislative district.
- c. Precincts shall be composed of contiguous territory within a single county. The boundaries of all precincts shall follow the boundaries of areas for which official population figures are available from the most recent federal decennial census.
  - d. All election districts shall be drawn to standards of Chapter 49.

SECTION 7. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication as required by law.

- The final request for abatement was on a parcel owned by the City of Sioux Center. This is now an exempt property. Motion by Bloemendaal and supported by Kleinwolterink to abate taxes on a parcel of property owned by the City of Sioux Center. Motion carried unanimous in favor, one member absent.

11-09-26 3 Shane Walter, Sioux County Community Services Director

- Attended a meeting with the Mental Health Consortium. The Consortium consists of 9 counties in the northwest corner of Iowa. A lengthy meeting was held with mental health providers. Walter reported that there will be regionalization because of likely legislation in the upcoming year. The counties in the Northwest Iowa Consortium work together with the providers to negotiate rates in this region, which may prove to be a model for other regions in Iowa.
- As this was the date and 10:00 a.m. the time set for a public hearing for the construction of a new deep pit 2,400 head swine finishing barn in Section 3 of Reading Township, said hearing was held according to law. The plan was submitted by Gerald R. Postma. The Chairman opened the meeting. Gerald Postma was present for this discussion. Shane Walter, Zoning Administrator stated that this plan meets matrix requirements. No public comments, either written or oral, were received. The Chairman closed the public hearing. Motion by Kleinwolterink and supported by Wright to forward the request to the DNR with a favorable recommendation. Motion carried, unanimous in favor, one member absent.
- A waiver for the 14 day waiting period before construction begins was requested by Gerald Postma for the aforementioned construction project. Motion by Bloemendaal and supported by Kleinwolterink to approve a waiver for the 14 day waiting period to begin construction pending approval by the DNR. Motion carried, unanimous in favor, one member absent.
- 11-09-26 4 Micah Van Maanen, Sioux County IT Director told the Board that the wireless network is complete, and that the project came in \$4,000.00 under budget. Because of the upgrade, video updates are faster at the Sheriff's department. The Attorney's Office is pleased with the speed of the network. Van Maanen also informed the Board that the virtual server project is progressing well and is nearly 90% complete.

# 11-09-26 5 Doug Julius, Sioux County Engineer

- Asked for the approval of two permit agreements:
  - 1. WesTel Systems Run fiber optic from Hwy 10 northeast on Kennedy in Section 35 of Holland Township.
  - 2. Bar K Cattle LLC Run water line and electrical wire in conduit under 270<sup>th</sup> Street in Section 4 of Settlers Township.

Motion by Wright and supported by Kleinwolterink to approve the aforementioned permit agreements. Motion carried, unanimous in favor.

- Requested the Chairman's signature on two "Certification as to Completion of Work" documents. Projects certified were: L-4-2011—73-84-CULV, a twin pipe arch culvert located on 360<sup>th</sup> Street in Capel Township and L-4-2010—73-84-CULV a triple pipe arch culvert located on 380<sup>th</sup> Street in Lynn Township.
- Presented an update on 2011 construction projects. Noted that a bridge in Washington Township is closed because of a problem with its superstructure. A high voltage electric line goes over the bridge, making repairs very difficult. Julius said that he may consider making this a level B low maintenance road.

• Requested Board approval for the purchase of a new Wheel loader. Motion by Bloemendaal and supported by Wright to approve the replacement of a 936E Wheel Loader with a 2011 938H Wheel Loader at a cost of \$147,460.00 Motion carried, unanimous in favor, with one member absent. This piece of equipment will go to the Hawarden Shop.

#### **11-09-26 6** COMMITTEE REPORTS:

- **Kleinwolterink** Building Committee Report: Worked with Russ Krull about adding a security entrance to the north door of the Courthouse. Attended a RWIB (Regional Workforce Investment Board) meeting.
- **Bloemendaal** Went to Spencer to attend a RIDES meeting. That agency reported having positive fund balances. Attended a NW Iowa Planning meeting nothing to report. Attended a shooting demonstration at Sandy Hollow.
- Wright Attended a Mental Health consortium meeting.
- **Sybesma** Attended a Legislative Policy meeting. Sybesma reported that Mental Health redesign and road use tax issues appear to be the hot topics for the upcoming legislative session.
