Ali Child, Account Manager for Wellmark of Mason City Service Center, met with the Board this date to introduce herself and review the Wellmark services available to Sioux County.

Dennis Sassman, County Community Services Director, met with the Board this date to request approval and a Chairman's signature on a First Amendment to a State of Iowa Lease Agreement.

Motion by Smith and supported by De Haan to approve and authorize the Chairman to sign a First Amendment to a State of Iowa Lease for the benefit of the Iowa Department of Human Services, Case Management, in an amount of \$248.60 per month for 190 square feet of office space including a proportionate share of common space located at 215 Central Ave. SE, Orange City, Iowa. This amended lease would cover the period February 1 through June 30, 2000. Carried, unanimous in favor.
