- **14-01-14 1** The Board of Supervisors of Sioux County, Iowa, met on January 14, 2014, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.
- **14-01-14 2** Minutes of the meeting held on January 7, 2014, were submitted and the Chairman declared the minutes approved.
- **14-01-14 3** Motion by Degen and supported by Kleinwolterink to appoint Dennis Brunsting as Township Clerk for Sheridan Township for a term ending on December 31, 2013. Motion carried, unanimous in favor.
- **14-01-14 4** Anita Van Bruggen, Sioux County Recorder, presented the Recorders Quarterly report for the quarter ending December 31, 2013. The report was accepted for information.
- 14-01-14 5 Steve Christensen, representing the Granville Fire and Rescue Department, reported that things are progressing for building a new Fire Station. A site has been chosen. Estimates for demolition and asbestos removal are coming in. \$320,000 has been collected of the estimated \$500,000 project. Motion by Degen and supported by Kleinwolterink to provide \$5,000 each year for the next three years for this project beginning in Fiscal Year 2015. Motion carried, unanimous in favor.
