- **07-05-15 1** The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Dennis Wright, Vernon Beernink, Mark Sybesma, John Degen and Arlyn Kleinwolterink.
- **07-05-15 2** Minutes of the meeting held on May 1, 2007, were submitted and the Chairman declared them approved.

07-05-15 3 Coleman McAllister, County Attorney

- Introduced summer intern, Nick Zevenbergen, a 2nd year law student.
- Reported that a three year grant of \$19,300.00 was awarded for the crime victims witness coordinator program. McAllister is planning to fund the remainder of the Victim Witness Coordinator's wages through fine collection.
- Distributed a summary of fine collections.
- Informed the Board that the sound system in the Courtroom is still not working properly. IT Director Micah Van Maanen stated that the problem will be addressed next week.

07-05-15 4 Dan Altena, County Sheriff

RESOLUTION TO AMEND DATA PROCESSING AND AUDITOR DEPARTMENT BUDGETS

WHEREAS, proposed expenditures for the Data Processing Department will cause this Department to exceed the amount budgeted for the fiscal year 2006-2007; and

WHEREAS, it is deemed necessary to increase the appropriations for the Data Processing Department to not be in violation of Iowa Code Section 331.437; and

THEREFORE, BE IT RESOLVED by the Board of Supervisors that the appropriation for the following Departments be changed as follows:

Data Processing Department be increased from \$223,465 to \$273,465

Auditor's Department be decreased from \$609,148 to \$559,148
