

**MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS**  
**MEETING HELD ON DECEMBER 4, 2012**

**12-12-04 1** The Board of Supervisors of Sioux County, Iowa, met on December 4, 2012, at 9:00 o'clock a.m. with Chairman Mark Sybesma presiding. Members present were Al Bloemendaal, John Degen, Arlyn Kleinwolterink, Mark Sybesma and Dennis Wright.

**12-12-04 2** Minutes of the meeting held on November 20, 2012, were submitted and the Chairman declared them approved.

**12-12-04 3** The Regional Airport Board has requested that the County issue a check for its annual contribution before the end of the year. Because some landowners wish to complete the transaction to sell their land in 2012, the Airport Board requested a loan from the County in the amount of 2.8 million dollars. The Auditor was instructed to prepare the claims for payment.

**12-12-04 4** Doug Julius, Sioux County Engineer

- Requested that the Board approve a permit agreement for Southern Sioux Rural Water to bore a 2 ½ inch PVC water line under K-18 between Sections 1 and 2 in Logan Township. Motion by Degen and supported by Kleinwolterink to approve the permit agreement as submitted. Motion carried, unanimous in favor.
- Submitted the annual Weed Commissioner's report. Motion by Wright and supported by Bloemendaal to approve the 2012 Weed Commissioner's report. Motion carried, unanimous in favor.
- Received notice this morning that the City of Rock Valley has been granted federal funding for county bridge funds. It is likely that 1 million dollars could be received for the bridge north of Rock Valley. The bridge would need to be completed within the next three years.

**12-12-04 5** Dan Altena, Sioux County Sheriff reported on ongoing activity in the Sheriff's Department. The Communications Center keeps very busy with calls. Civil paperwork and the issuance of weapons permits are also areas of the office that are busy. A special response team has been formed. The team consists of the Plymouth County Sheriff's Department, the LeMars Police Department and the Sioux County Sheriff's Department. The 10 year contract with the Federal Marshall for housing federal prisoners will expire next year and will need to be renewed.

**12-12-04 6** The Sioux County Library Board Association met with the Board to present their budget request for FY 2014. Pat Plagge, representing the Library Board thanked the Board for their help in the past. She informed the Board that libraries are open to everyone, and that they continue to provide more services, especially in the area of new technology. The libraries are requesting a 4% increase in the amount requested in County support.

**12-12-04 7** Shane Walter, Sioux County Community Services Director

- Reported that a model ordinance was sent to him in regard to establishing a County Ordinance that would prevent the construction of tall structures in the area of the proposed airport. The Regional Airport Board will have a meeting in February at which time Walter will ask questions of them about the wording of the ordinance. Re-zoning the area will also need to be addressed by the Planning and Zoning Board and then forwarded to the Sioux

County Board of Supervisors. Walter recommended that the Board set aside some time at a future meeting to discuss the model ordinance.

**12-12-04 8** COMMITTEE REPORTS: **Bloemendaal, Kleinwolterink, Sybesma and Wright** – Attended various meetings during ISAC (Iowa State Association of Counties) in Des Moines. Sessions that they attended included funding for Secondary Roads, promoting the installation of wind turbines and business etiquette.

**12-12-04 9** Claims submitted by the Auditor were approved for payment.

**12-12-04 10** The Chairman adjourned the meeting at 10:45 a.m. The next meeting will be held on December 11, 2012, beginning at 9:00 a.m.
