## MINUTES OF SIOUX COUNTY BOARD OF SUPERVISORS MEETING HELD ON JUNE 13, 2017

- 1) The Board of Supervisors of Sioux County, Iowa, met pursuant to adjournment at 9:00 a.m. with Chairman Sybesma presiding. Members present were John Degen, Arlyn Kleinwolterink, Dennis Wright, Al Bloemendaal, and Mark Sybesma.
- 2) Minutes of the meeting held on May 30, 2017, were submitted, and the Chairman declared them approved.
- 3) The claims were approved as submitted by the County Auditor. The Board noted that a drone was purchased by the Sheriff's Department as a non-budgeted item for \$15,366.76, similar to last year when a skid loader was purchased and was not budgeted for.
- 4) A written request was made by Carol Borchard and Dori Wallenburg to use the Courthouse grounds for a Bible reading marathon on July 7-8. The Board approved this request.
- 5) Ryan Dokter, Sioux County Auditor,
  - Requested that the Board sign a resolution appropriating 75% of the amount budgeted for FY 2017/2018. Motion by Wright and supported by Bloemendaal to approve a resolution appropriating 75% of the funding for FY 2017/2018. Roll call on vote: Kleinwolterink, Yes; Degen, Yes; Bloemendaal, Yes; Wright, Yes; and Sybesma, Yes. Motion carried, unanimous in favor.

## **RESOLUTION 2017-21**

WHEREAS, it is desired to make appropriations for each of the different offices and departments for fiscal year 2018 in accordance with Section 331.434(6), Code of Iowa,

NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors of Sioux County, Iowa as follows:

- SECTION 1. The amounts itemized by fund and by department or office on the attached schedule are hereby appropriated at 75% of total expenditures for each department, as listed in the last column on the same line of the attached schedule.
- SECTION 2. Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized funds.
- SECTION 3. In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditures of money for a purpose in excess of the amounts appropriated pursuant to this resolution.
- SECTION 4. If at any time during the fiscal year 2018 budget year the Auditor shall ascertain that the available resources of a department for that year will be less than said department total appropriations, he shall immediately so inform the Board and recommend appropriate corrective action.
- SECTION 5. The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate the amount of the appropriation, the amounts charged thereto, and the unencumbered balance. The Auditor shall report the status of such accounts to the applicable departments and officers monthly during fiscal year 2018 budget year.

SECTION 6. All appropriations authorized pursuant to this Resolution lapse at the close of business on June 30, 2018.

## **RESOLUTION NO. 2017-22**

Pursuant to Iowa Code §368.7(1)(b)(2), a resolution is required from the Board of Supervisors of the County for which the proposed real estate is to be annexed. The City of Granville, Iowa has notified Sioux County that the City of Granville, Iowa will hold a public hearing and will take action on the Application for 100% Voluntary Annexation at the City Council's meeting to be held at 7:00 P.M., on June 15, 2017, in Granville City Hall, at 740 Broad Street, Granville, Iowa 51022.

The Voluntary Annexation of the following described real estate to the City of Granville, Iowa; a map of said territory proposed to be adopted and its location in relation to the City of Granville, Iowa, is attached to this Resolution and marked as Exhibit A.

A parcel of land located in the SE1/4 of Section 2, Township 94 North, Range 43 West of the 5<sup>th</sup> P.M., Sioux County, Iowa, more particularly described as follows:
