### SIOUX COUNTY RESOLUTION NO.: 2017-26

#### CITY OF HOSPERS, IOWA RESOLUTION NO. 2017-10

- WHEREAS: The Board of Supervisors of Sioux County, Iowa are empowered under authority of Sections 321.236 and 321.255 of the Code of Iowa to study and determine the safety condition on any secondary road/extension under their jurisdiction from conditions existing and may determine the proper safety measures
- WHEREAS: Sioux County, Iowa and the City of Hospers, Iowa have concurrent jurisdiction over the extension of 400<sup>th</sup> Street (B40) from the intersection of 400<sup>th</sup> Street and Hospers Drive South to the intersection of 400<sup>th</sup> Street (B40) and Iowa Hwy. #60
- WHEREAS: The City of Hospers, Iowa has requested that "No Parking This Side of Street" signs be placed on the northside of Birch Street (400th Street/B40 Extension) for the safety of the traveling public, pedestrians, adjacent residences

## SIOUX COUNTY RESOLUTION NO.: 2017-27

WHEREAS: The Sioux County Board of Supervisors is empowered under authority of Sections 321.236, 321.255 and 321.345 of the Code of Iowa to designate any secondary road intersection under their jurisdiction as a STOP intersection and to erect STOP signs at one or more entrances to such intersections, and

WHEREAS: Traffic on 320th Street west of IA Hwy #75 at Perkins, Iowa has increased due to a business's growth, road improvements, and paved surface and is endangered by traffic from the north on Perkins Drive at the intersection of 320th Street and from the north on Perkins Avenue at the intersection of 320th Street in the SW ¼ SE ¼ of Section 29, T97N, R45W (Lincoln Township)

NOW THEREFORE BE IT RESOLVED by the Sioux County Board of Supervisors that the roadway approaches from the north on Perkins Drive and Perkins Avenue be designated "STOP Approaches" to the above described intersections and that STOP signs be erected accordingly.

WHEREAS, The Sioux County Board of Supervisors hereby waives its right to appeal the issuance of the final permit within the fourteen (14) day limit from the time of receipt of notice of the issuance of the draft permit, AND

WHEREAS, The Sioux County Board of Supervisors encourages the Iowa DNR to issue the Final Permit immediately upon notification of this waiver, AND

WHEREAS, The Sioux County Board of Supervisors authorizes the Board Chairman to notify the Iowa DNR of this waiver, AND

WHEREAS, This resolution shall take effect immediately,

#### FIRST AMENDMENT TO NOTE AND LOAN AGREEMENT

This First Amendment to Note and Loan Agreement ("Amendment") is entered into October 17, 2017, by and between Sioux County, Iowa (the "County") acting through its Board of Supervisors and American Bank, NA, Le Mars, Iowa (the "Lender").

#### **RECITALS**

- A. The Lender and the County are parties to a Loan Agreement dated March 15, 2017 (the "Loan Agreement"), pursuant to which the Lender agreed to loan the County the sum of \$4,850,000.00, subject to the terms and conditions of the Loan Agreement (the "Loan"). The Loan is evidenced by an Urban Renewal Revenue Capital Loan Note Series 2017 (Certificate No. 1) in the original principal amount of \$4,850,000.00 (the "Note").
- B. The County issued the Note pursuant to a Resolution adopted by the County on February 28, 2017, which resolution is entitled "A Resolution Approving and Authorizing a Form of Loan Agreement and Authorizing and Providing for the Issuance and Securing the Payment of \$4,850,000 Urban Renewal Revenue Capital Loan Notes, Series 2017, of Sioux County, State of Iowa, Under the Provisions of the Code of Iowa, Providing for a Method of Payment of the Notes and Approval of the Tax Exemption Certificate (the "Resolution"). The Note is the only Urban Renewal Revenue Capital Loan Note issued pursuant to the Resolution.
- C. The Loan Agreement and the Note each provide that the County must repay the Loan in accordance with the payment schedule attached to the Note as Exhibit A.
- D. The County desires to alter the payment schedule to provide for certain accelerated payments without altering the maturity date of the Note, and the Lender is agreeable to such changes to the payment schedule, as set forth in this Amendment.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is acknowledged, the Lender and the County agree as follows:

- 1. <u>Repayment Schedule</u>. The Lender and the County agree that the Loan shall be repaid by the County in accordance with the attached payment schedule marked as "First Amended Exhibit A", which shall supersede and replace Exhibit A to the Note.
- 2. <u>Consent to Amendment</u>. By executing this Amendment, the Lender consents to the modification of the terms of repayment of the Note as set forth in this Amendment.
- 3. <u>No Novation</u>. This Amendment does not constitute a novation of the Note. All of the terms and conditions of the Note and the Loan Agreement remain in full force and effect, except as expressly modified herein.
- 4. <u>Binding Obligation</u>. The County acknowledges the Note and the Loan Agreement remain the legal and binding obligations of the County.
