Explanation of increases in the budget:

General Fund received local government relief funds so no increase was needed. Rural fund has seen growth due to the local option sales tax receipts, so less tax collections are needed.

Budget year effective property tax rate is the rate that would be assessed for these levies if the dollars requested is not changed in the coming year.
