

## Sioux County Deputy Sheriff Job Opening Effective 6/2/22

Have you ever considered an exciting career in law enforcement? Are you interested in working for a well-regarded organization, focused on the safety and betterment of the Sioux County community? Then this position may be for you! The Sioux County Sheriff's Office is looking to hire dedicated, professional, and driven individuals for open Deputy Sheriff positions. The position, application process, and hiring process are outlined below.

**Status:** Full-Time

**Location:** Orange City, Iowa

**Starting Pay:** \$35.77/hour

**Benefits:** Full-time employment comes with access to affordable health, dental, & vision insurance, IPERS contributions, and additional voluntary benefit opportunities.

### **Application Process:**

Application packets can be requested via phone or email by contacting the Civil Service Commission Personnel Director at 712.737.2216 or michellem@siouxcounty.org. Applications must be completed and received by June 30, 2022 at 4:30 pm to be considered for potential employment.

### **Civil Service Commission Process:**

After submission of a completed application, applicants will be required to attend Civil Service Testing scheduled for July 12, 2022 starting at 8:00 am. Testing day is mandatory for consideration and will not be rescheduled for any reason. Testing day includes a physical agility test, written test, and oral interviews with the Sioux County Civil Service Commission. Following testing day, applicants who pass all requirements will be placed on a certified list for the County Sheriff to select from. This certified list is valid for 1 year following testing.

### **Minimum Requirements for Iowa Law Enforcement Officers:**

- Be a U.S. Citizen and a resident of Iowa, or intend to become a resident upon being employed
- Be 18 years of age at time of appointment
- Hold a valid Iowa driver's license
- Not be addicted to drugs or alcohol [modified for Chapter 400 civil service positions by §400.17 of the Code of Iowa]
- Be of good moral character as determined by a thorough background investigation including a fingerprint search conducted of local, state, and national fingerprint files and have not been convicted of a felony or a crime involving moral turpitude
- Successfully pass physical fitness test(s)
- Not be opposed to use of force to fulfill duties
- Be a high school graduate or hold a GED certificate
- Have uncorrected vision of not less than 20/100 in both eyes, corrected to 20/20, and color vision consistent with the occupational demands of law enforcement
- Have normal hearing in each ear
- Be examined by a physician and meet the physical requirements necessary to fulfill the responsibilities of a law enforcement officer
- Undergo psychological testing
- Undergo cognitive (Basic Skills) testing
