

NOTICE IS HEREBY GIVEN TO THE ELIGIBLE VOTERS OF SIOUX COUNTY, IOWA,
AND LYON COUNTY, IOWA, THAT THE ROCK VALLEY SCHOOL SPECIAL
ELECTION WILL BE HELD ON TUESDAY, SEPTEMBER 13, 2022

The polls of said election will be open from 7:00 a.m. until 8:00 p.m.

For the Rock Valley Community School District Special Election to be held on September 13, 2022 voting centers will be available. Any registered voter of the Rock Valley Community School District may vote at any of the following places in this election:

The polling location for this election is handicapped accessible; however, any voter who is physically unable to enter the polling place has the right to vote in the voter's vehicle. Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing addresses must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence to the polling place before the polls close on election day or to the county auditor's office by 12:00 PM, Monday, September 19, 2022. Election Day Registrant attestors must provide an approved form of identification. All voters are advised as to the requirements of voter registration in order to be eligible to vote at said election. If you are challenged as unqualified to vote, you may cast a ballot in accordance with section 49.81, Iowa Code.

Public testing of the voting equipment will be conducted at the Sioux County Courthouse the week of August 29th from 8:00a.m. – 4:30p.m. Absentee and special voter ballots will be counted at the Sioux County Courthouse.

Shall the Board of Directors of the Rock Valley Community School District in the Counties of Sioux and Lyon, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$25,000,000 to be used together with sales tax revenue to provide funds to build, furnish and equip a high school addition to the existing facility, including a related parking lot and other site improvements; and to remodel, repair, and improve the existing facility and site?
