To register or transfer a boat you will need:  
title (17' or longer) & or registration signed off by seller, bill of sale & the attached application form filled out & signed on the 2<sup>nd</sup> page.

### **To transfer a boat that is registered in Iowa & current for 2025:**

\$6.50 to transfer the registration  
\$13.50 for title on boats 17' or longer  
\$13.50 for lien  
7% sales tax of purchase price.
